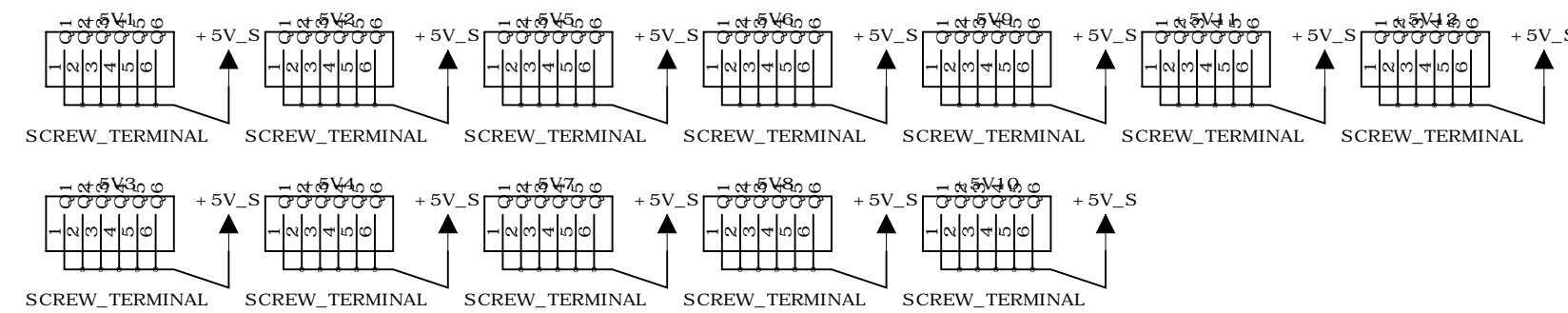
Ground Taps
